The Government of Nepal [GoN] has allocated funds towards the cost of 15 Bed Hospital Construction at Devchuli Municipality, Devchuli-3 and intends to apply part of the funds to cover eligible payments under the Contract for 15 Bed Hospital Construction at Devchuli Municipality, Devchuli-3 (Contract No: DEV/NCB/WORKS/05/2077-078). Bidding is open to all eligible bidders as per Section V of Bidding Document Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Devchuli Municipality or may visit PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).

Devchuli Municipality, Nawalparasi-East invites electronic bids from eligible bidders for the construction of 15 Bed Hospital Building Construction Including Civil, Electrical, Sanitary, HVAC, Fire fighting, Compound and Land Development works etc. under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 120000000.00
  - Minimum Work experience of similar size and nature: Single Building Project cost of 128000000.00
