The Government of Nepal [GoN] has allocated funds from towards the cost of Bhatbhateni chowk dekhi Bahrakol-Belswara Sadak Nirman Works and intends to apply part of the funds to cover eligible payments under the Bhatbhateni chowk dekhi Bahrakol-Belswara Sadak Nirman Works. (Contract No.: - DEV/NCB/WORKS/25/2076-077). Bidding is open to all eligible as per Section V of bidding document..
2. ***Devchuli Municipality,Nawalparasi-East*** invites electronic bids from eligible bidders for the construction of Bhatbhateni chowk dekhi Bahrakol-Belswara Sadak Nirman Works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 10,20,00,000.00**
 - Minimum Work experience of similar size and nature: **At least 1 Contracts within the last ten (10) years with a value of at least NRs 6,36,00,000.00. that have been successfully or are substantially completed and that are similar to the proposed works.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of ***Devchuli Municipality,Nawalparasi-East*** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder who chooses to submit their bid electronically should download the bidding documents for e-submission from PPMO's e-GP system, www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of non-refundable fee of 5000 as bidding document in the Project's Rajaswa (revenue) account as specified below .

8. Electronic bids must be submitted to the office **Devchuli Municipality,Nawalparasi-East** through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00** on 2020-04-05(2076-12-23). Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2020-04-05(2076-12-23) 13:00 hours at the office of **Devchuli Municipality,Nawalparasi-East** . Bids must be valid for a period of 90 **days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum Of 20,00,000.00 which shall be valid for 30 days beyond the validity period of the bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
